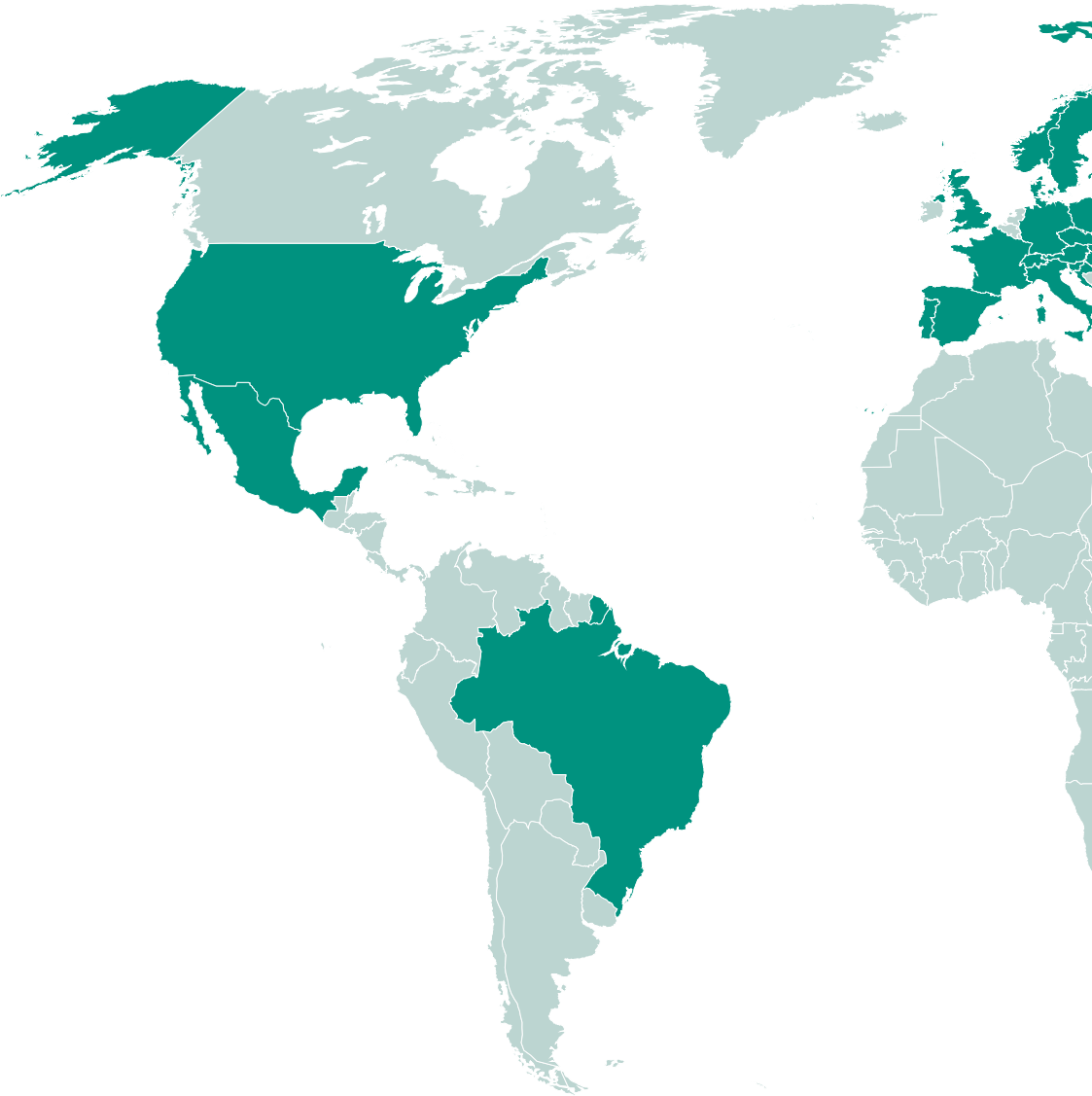
OUTSOURCING SERVICES

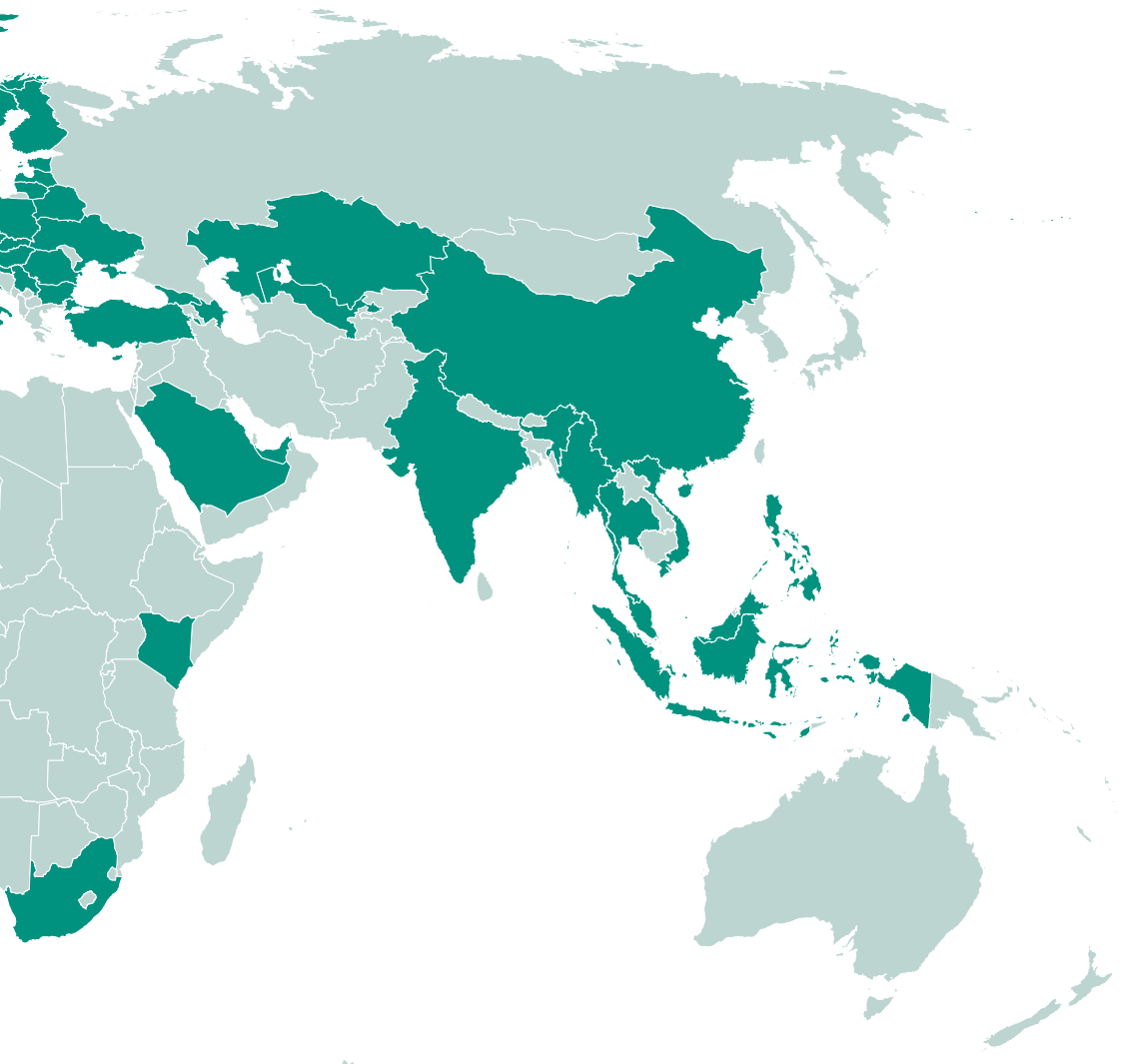

- a client in the timber related industry on the acquisition of a production company in Malaysia and on its Group restructuring.

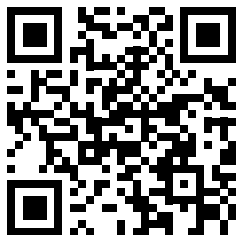
